## **TEAM INFORMATION** (Please read and sign!)

- All members will compete, dance, and train only for/with Capitol Dance Company, and not for any other
  dance studios during our competition season (August 2023 to May 2024). Any outside activity such as
  dance, theatre, cheer, or sports teams that conflict with required classes/competitions are not permitted
  for CDC competition members. All dancers who wish to participate in school dance teams must get
  direct permission from Ms. Allison/Director only, and it is not guaranteed.
- All members are required to pay a commitment fee (\$500 per dancer).
- All members are **required to take a minimum number of classes** and maintain excellent attendance.
- All dancers must have a **positive and professional attitude** in class and during competitions as they are representatives of CDC.
- All parents are expected to have respectful behavior with all CDC staff, dancers, and parents.
- Competition dancers attend a minimum of **5 regional competitions.** <u>ALL ARE MANDATORY</u>. CDC competition schedule for the year will be sent out in August.
- Being on a competitive dance team is exciting and fun, but it is also hard work! It needs the dedication of parents, dancers, and staff to make it work.

# **SOLOS & DUO/TRIO INFORMATION** (Please read and sign!)

- There is NO SEPARATE AUDITION for solos, duos, and trios. Eligibility for any requires you to dance on at least one team and to have danced for CDC for at least one year. This rule may vary depending on transferring experienced soloists from other studios who are joining CDC.
- Solos, duos, and trios will require additional fees to cover choreo/coaching costs: choreography fees are \$475 for solos and \$275 for duo/trios per dancer. \$75 per rehearsal will be due after choreography is complete.
- Level placement will be determined by the director only.

I agree that my child may apply for a solo and/or duo/trio, and I understand that their placement, coach, style, and level is at the Director's discretion. I accept that I will incur additional choreography/coaching fees IF my child is selected for a solo, duet, or trio.

Dancers are required to make a significant dedication of their time to train with CDC at an accelerated level, are expected to be available weekly for any and all rehearsal or performance opportunities and to behave in a mature, independent, professional and collaborative manner with other dancers, guest choreographers and all staff. Dancers **cannot have conflicting schedules** outside of "The Company". The Director will select dancers based on the above AND in weekly in-class work ethic, professional performance day mindset, all CDC staff input and technical achievement.
